



We dedicate these proceedings to his loving memory.



#### SYNOPSIS OF THE GRAND ASSEMBLY JUNE 26, 2010 ~ WILLMAR, MINNESOTA

The Annual Assembly of the Grand Council of Cryptic Masons of Minnesota was opened in ritualistic form by the officers and members of Minneapolis Council No. 2, the home Council of Most Illustrious Grand Master Ronald A. Miles, personally greeted and thanked all who participated.

A roll call of the Councils indicated that twelve (12) of the thirteen (13) councils were present constituting a quorum. Only Southgate No. 15-Albert Lea was absent.

The Pledge of Allegiance to the United States flag was made followed by a tribute presented by Hugh C Swift, jr. serving as Grand Commander of Knights Templar in Minnesota this year. Tribute to the Canadian Flag was given by John C James of Manitoba.

The roll call of Minnesota's Past Grand Masters was made with the following answering:

Three (3) resolutions of Amendments to the Constitution and Rules and Regulations were presented for consideration.

- 1- Increase per capita from \$7.00 to \$10.00/member
- 2- Establishment of a Holding Council at the Grand Level
- 3- Exempt deployed military from per capita.

After discussion and amendments to remove ambiguity, the resolutions passed by the required margin.

The Altar Cloth for Increased Membership was won this year by Ark Council No.3 of Owatonna.

On unanimous approval, retiring Grand Treasurer/Grand Recorder Stanley Morrill was awarded the title of Emeritus for his over twenty years of recorded service to this Grand Council. Grand Master Ron Miles then presented him with a beautiful hand-crafted mantel clock which proceeded to chime the balance of the session.

#### Appointed Officers for 2010-2011 are:

James Melander-Grand Chaplain; James Turner-Grand Captain of the Guard; Michael Denke-Grand Conductor of the Council; Terrence Becker-Grand Marshall; Douglas Stevenson-Grand Steward; Cliff Isley-Grand Sentinel; and William Hubbard-Grand Organist. Hugh C Swift was appointed Grand ArchMaster.

Newly elected Grand Treasurer/Grand Recorder Pehle indicated that he will be relocating the office and banking facilities to Virginia, Minnesota and will share an office with the Royal Arch Grand Chapter. The budget was approved for the following year and should be close to being balanced with the per capita increase and the economies of scale to be achieved by combining the Offices of RAM and CM in one location.

Lawrence Weaver, the Right Puissant General Grand Principal Conductor of the Work was the personal representative of Most Puissant Joe Vale, the General Grand Master of the Grand Council, Cryptic Masons, International. He briefed the companions on several points including, Life Memberships in the General Grand Council, the Cryptic Mason Magazine, the "Lady of the Council" award, the York Rite Web site and finally on the charity and it's progress with stem cell research.

The 2010-2011 Grand Council officers present were installed by PMIGM Stanley Morrill.

Awards given at the banquet included Cryptic Mason of the Year to Dexter Pehle of Northfield #12; Adult Leadership to Cliff Isley of Central #14; and the Youth Award given to Jane Gross for her work with the Rainbow Girls.

### **GRAND ASSEMBLY**

The Grand Council of Cryptic Masons of Minnesota met in Grand Assembly on Saturday, June 26, 2010 at the Holiday Inn and Conference Center in Willmar, Minnesota. At the appointed time the assembly was called to order and Most Illustrious Companion Ronald A Miles presented the officers of Minneapolis Council No. 2, his home council, to ritualistically open the Assembly in proper form.

There was an alarm at the door and Most Excellent Grand Master Ronald A Miles and the corps of Grand officers entered the room arriving at the East. Companion Miles thanked Minneapolis Council No. 2 for opening and seated the assembly. He then introduced the Grand Officers for today:

Grand Master Miles acknowledged that the Pledge of Allegiance had already been given as part of the ritualistic opening and called upon Past Most Illustrious Grand Master Hugh C Swift, Jr. to render a Tribute to the United States American Flag. Companion Swift's tribute:

"Companions, Distinguished Guests and Friends, let us draw our attention to the flag of our beloved country. It is displayed in the East of every Masonic body where it is accorded the position of highest honor. It is the constant inspiration of every lover of his country and also to every true Knight of the Cross. It demands unswerving loyalty and whole-hearted devotion to the principles of which it is the glorious representative. Beneath its protective folds, Liberty, Equality and Fraternity are the heritage of every citizen, while the oppressed of many nations have found peace and happiness over the land over which it floats. The flags of mighty empires have come and gone but the stars and stripes remain. Alone of all flags it symbolizes the sovereignty which endures when all else passes away. And speaking with their voice it has the sanctity of revelation, that he who lives under it and is loyal to it, is loyal to truth and justice everywhere. And my companions, so long as this great flag flies, the government of the people, by the people and for the people shall not perish from this earth. Thank you"

The tribute to the Canadian Flag was given By Most Illustrious John C James of Manitoba, Past Most Illustrious Deputy General Grand Master for Western Canada:

"I present the Flag of Canada, symbol of harmony and unity. The red symbolizes the blood of our forefathers which we emulate; the white, that blameless purity of life and conduct to which we aspire. The points, the eleven knightly virtues for which we all stand for. This flag forcibly reminds us that on these moral qualities on which our confederation was founded and on their preservation its future can safely depend. And finally, it inspires in us the reverence to Him to whom we ever reverently pray. God save our Queen and Heaven bless the Maple Leaf forever. Long may it wave in harmony with the Stars and Stripes of the United States of America."

Grand Master Miles declared the Ballot Box open and instructed the companions to cast their vote during the upcoming break time. He appoint the three tellers; Companion Ray Frandsen as Chair, assisted by Companions Bruce Brendel and Vernon Schwalbe.

The Distinguished Guests and Visitors were asked to assemble outside the door, to be assisted by Past Most Illustrious Grand Master Loren Schroeder.

Presented were: John C James, Past Grand Illustrious Master of Western Canada, and Most Puissant Larry Weaver, Grand Principal Conductor of the Work for the General Grand Council of Cryptic Masons International and personal representative of the Most Puissant Joe Vale, General Grand Master of the General Grand Council of Cryptic Masons, International. Grand Honors were accorded to the visitors.

Grand Master Miles acknowledged that James Fischer was also Past MIGM of Iowa but was outside of the room at the present time.

Grand Recorder Stan Morrill <u>moved that the proceedings of the 2009 Session, printed</u> and distributed, be accepted as the minutes of the previous Grand Assembly. The motion was seconded and passed.

Most Excellent Companion Douglas Nygard – Grand High Priest and Right Eminent Sir Knight Hugh C Swift – Grand Commander were brought west of the altar where Grand Master Miles related his joy about traveling and working with them this past year. They each reiterated events that stood out in their memories of travels. Grand Master Miles thanked them for a great year.

Grand Recorder Stan Morrill <u>moved that the pre-printed reports be accepted except for</u> <u>the Budget and the Resolutions.</u> The motion was seconded and passed.

Grand Master Miles then recognized the Appendant Bodies. He wanted to acknowledge all the bodies and called for the members of the following to rise when their organization is named:

WHEREAS: In the past the investment income from our investments was sufficient to cover our operating expenses, but because of the collapse of the investment market there is not enough funds to generate money to operate this Grand Council.

RESOLVED THAT; ARTICLE X FINANCE Section 10.034 that now reads \$7.00 for each member reported in good standing by a Council in its annual return.

BE AMENDED TO READ; ARTICLE X FINANCE Section 10.034 to read **\$10.00** for each member reported in good standing by a Council in its last return.

### RESOLUTION 2010-2 RESOLUTION TO AMEND THE RULES FOR THE REGULATION OF CONSTITUENT COUNCILS

#### HOLDING COUNCIL

WHERE AS: Due to the loss of members or other reasons causing a Council to close or elect to close , and due to age or geographical problems, did not want to consolidate; and

- WHEREAS, A holding Council would offer members the chance to transfer to a new Council, with the goal of retaining membership, control over assets, property and records, and continued participation in the Craft; now therefore be it
- RESOLVED, That under *ARTICLE I COUNCIL UNDER DISPENSATION,* a new Section 2.05, be added to read:

#### HOLDING COUNCIL.

#### SubSection .01 HOW FORMED

The Holding Council known as *Grand Master Hiram* Council No. 13 UD, shall be formed by the granting of a dispensation to said Council No. 13 UD each year by the Most Illustrious Grand Master, in order that all rules and laws of the Grand Council would be complied with.

#### SubSection . 02 MEMBERSHIP

Membership shall be limited to Companions of constituent Minnesota Councils which have lost or surrendered their charters, or who demitted when their council ceased to exist. It is open to any companion who demitted or withdrew or was suspended from a merged or consolidated council. Petitions for Affiliation are acceptable when accompanied with a certificate of Good Standing. Dual membership within Minnesota is prohibited

#### SubSection .03 PROPERTY, RECORDS & FINANCES

All assets, property and records of any closed Council shall become the property of the *Grand Master Hiram* Council No. 13 UD. Revenues are derived from the dues of the members. Dues cards with the name *Grand Master Hiram* Council No. 13 UD and their previous Council would be issued from *Grand Master Hiram* Council No. 13 UD, using the same dues structure as their previous Council. Life Memberships shall be available based on the applicant's previous Council's dues structure. Dues notices and the

collection of the dues shall by accomplished by the Grand Recorder/ Treasurer. Demitted members seeking membership shall become members by application and the paying of the current year's dues. Members suspended for Non-Payment may restore membership upon application and payment of one and one-half times (1 & 1/2) current dues.

#### SubSection .04 OFFICERS & MEETINGS

The Officers of this Holding Council shall only be the Grand Council Officers for each year, who will retain their membership in their home Council and not pay dues to *Grand Master Hiram* Council No. 13 UD . The Grand Recorder/Treasurer shall be retained as a permanent officer of the Holding Council. The Annual Meeting will be held during the Grand Assembly session each year.

#### **RESOLUTION 2010-3**

#### RESOLUTION TO AMEND THE RULES AND REGULATIONS OF CONSTITUENT COUNCILS

#### ACTIVE DUTY MILITARY

WHERE AS: A small number of members of the Constituent Councils have been called to duty in the Military Forces of the United States and have been deployed.

NOW THEREFORE BE IT RESOLVED THAT: ARTICLE X FINANCE : That Section 10.02.1 Suspension of Dues be added.

Section 10.02.1 Suspension of Dues: To read: Any member of a Council serving in the Armed Forces of the United States shall have his dues remitted , while being deployed

NOW THEREFORE BE IT RESOLVED THAT: ARTICLE X FINANCE: Section 10.034 Which now reads \$7.00 for each for each member reported in good standing by a Council in its last annual report be amended to read:

The current per capita for each member reported in good standing by a Council in its last annual return unless the a member has his dues remitted while serving stateside or in foreign countries in the Armed Forces of the United States during times of war or conflict. This resolution will apply to any Cryptic Council member who is serving in the United States Air Force, United States Marine Corps, United States Navy, United States Army, and the United States Coast Guard; or in their respective reserves either serving stateside or serving in foreign countries during times of war or conflict. These companions will have their dues remitted by the

Grand Council of Cryptic Masons of Minnesota. Such dues remittance will begin to those active or reserve military personnel serving as of January 1,2011.

This constituting the first reading of the resolutions, Jurisprudence yielded the floor until after the recess, postponing any discussion or action until that time.

Grand Master Ronald A Mile then rose to give remarks.

"There were complaints about the noise from the base and its airplanes. Forgetting that it was there long before they were, a certain Lt Cornel in Luke Air Force Base deserves a big pat on the back. Apparently, an individual who lies somewhere near Luke Air Force Base wrote the local paper complaining about a group of F16's that disturbed his or her day at the Mall.

<u>The Complaint</u>. "Question of the day for Luke Air Force Base. Whom do we thank for the morning air show? Last Wednesday, at precisely 9:11 a.m., a tight formation of four F16's made a low pass over Arrowhead Mall, continuing West over Bell Road by approximately 500 feet. Imagine our good fortune. Do the Tom Cruise want-a-be's feel that they really need a wakeup call. Or were we just trying to impress the cashiers at Mervyn's early bird specials."

The response. (If I get through this it's good),

"Regarding a wake up call from Luke's Air Force Base on June 15 at precisely 9:12 a.m. a perfectly timed four ship flyby of F16's from the 63<sup>rd</sup> Fighter Squadron at Luke Air Force Base flew over the grave of Captain Jeremy Fresco. Captain Fresco was an Air Force Officer who was previously stationed at Luke Air Force Base and was killed in Iraq on May 30<sup>th</sup>, Memorial Day. At 9 a.m. on June 15<sup>th</sup> his family and friends gathered at Sunland Memorial Park in Sun City to mourn the lost of a husband, son, and friend. Based on the letter writer's recount of the fly by and just because of the jet noise, I'm sure that you didn't hear the 21 gun salute, the playing of taps, or my words to the widow and parents of Captain Fresco as I gave them their son's flag on behalf of the President of the United States and all their veterans and service men and women who understand the sacrifice they have entered. The four ship fly-by is a display of respect the Air Force gives to those who give their lives in the defense of freedom. We are professional aviators and take our job seriously and on June 15<sup>th</sup> when the letter writer witnessed. was four officers lining up to pay their ultimate respects. The letter writer asks, who do we thank for the morning air show? The 56<sup>th</sup> Fighter Wing will make that call for you, and forward your thanks to the widow and parents of Captain Fresco and thank them for you. For it was in their honor that my pilots flew the most honorable formation of their lives. Letter signed by Lt. Colonel Grant Rosensteel, Jr. the United States Air Force.

I had to share that with you. One of my co-workers sent that over to me. I thought that was just something I had to share with you guys. That is something. (clapping)

At this time I would like to do the roll call of the Grand Representatives. I do have a couple of certificates to hand out at this time. Stan Morrill can you do that for us.

Grand Master Miles presented Companion Melander with a letter of his appointment and his Commission from the State of Illinois,

The Altar Cloth for increase in membership was again awarded to Ark Council No. 3. The members in attendance were assembled before the altar and presented with cloth by Grand Master Ronald Miles and General Grand Principal Conductor of the Work Lawrence Weaver.

Companion Miles continued his remarks: "Here we go. Now I know not to stand under that thing." (Referring to the speakers) "It's really been kinda cool representing you as I travel throughout Minnesota to the different councils. No! I did not get to every council. However I believe I communicated by telephone, e-mail, what have you with the various councils throughout the State of Minnesota. Those that I missed, don't be surprised if I show up on your doorstep some evening saying, 'Here I am.' But it was really, the first couple of weeks being your Illustrious Grand Master; I've got to tell you guys, Tough. Really, really, really, really tough, and it was very sad. I still have trouble with it once and a while. I do get weepy-eyed; I'm sorry. That's the way I am. But I have really enjoyed representing you. And I hope that I have served you well, because that's what a leader does. What a leader does is serve those. There's no better definition of that, I can't think of anything. When I attended your councils, I was warmly received and I had Patti with me, so greatly received. Sometimes she gets a better reception that I do. When ever we travel, out to the different jurisdictions, whether it be South Dakota, whether it be lowa, whether it be anywhere we go, North and South Dakota, you guys were absolutely fabulous in the hospitality and that. I want to thank you from the bottom of my heart. The memories are something that will always, always stay with me. Each one of you is very, very near and dear to me and I will go out of my way to help you. I believe I did that last year, serving as you Illustrious Grand Master. And going forward I would do that too. If you need anything, please call me. That's what we do; we serve. I don't really have anything else. Is there any comments, any questions or anything? I know I'm opening it up."

There was one comment from the floor by Companion Dexter Pehle, who, on behalf of the Proceedings thanked the Grand Master for using the microphone since the Proceedings of the Assembly will be transcribed.

Companion Miles continued: "I've got to give Stan a little grief here. Stan has been on me to get the quote Official picture taken. If you notice the one we have in the book it's me in my purple sport coat and a tie, and I thought it looked pretty dog gone good. They can do a lot by making me look good with touch-up and Photoshop and everything else. But, I did get an official Picture taken with my collar and apron and jewel. And I want you to know that I did it in a timely manner. I did that a week ago Monday."

Companion Morrill comment that he asked for it in January. Miles continued: "Now, that's not too bad. Fellows, thanks again. It's been great serving you. Have a great day."

Grand Master Miles then declared a twenty minute recess break, and the companions mingled.

AT the end of the break, Grand Master Miles declared the Assembly to again be at labor. He inquired if all had balloted. He then proceeded to do a countdown to the time at which the Ballot Box would be closed. When all had indicated that they had voted, he declared the Ballot closed and directed the Tellers to perform their duties.

Grand Master Miles then called for the second reading of the resolutions. Companion Swift proceeded to read the Resolutions

Resolution 2010-1; To raise the per capita paid to Grand Council, from \$7 to \$10 starting at the end of this year. Companion Swift <u>moved for adoption of Resolution 2010-1</u>; seconded by Jurisprudence. Grand Master Miles explained the rules for discussion: up to three speaking against, each for only two minutes and alternating positions. Grand Recorder Morrill spoke in favor and cited the proposed budget as a need. Motion passed

Resolution 2010-2; The establishing of a Holding Council. Companion Swift <u>moved for</u> <u>adoption of Resolution 2010-2</u>; seconded by Jurisprudence. Companion Dexter Pehle, one of the co-authors spoke to modify by deleting the prohibition on dual membership. It created a conflict with the Grand Officers being able to serve as the officers of the holding council. Companion Pehle <u>moved to amend by deleting the last sentence in Subsection point zero two (.02)</u>. The motion was seconded and passed. There being no further discussion the motion, as amended, was voted on and passed.

Resolution 2010-3; Remittance of per capita dues for Military members on active duty. Companion Swift <u>moved for adoption of Resolution 2010-3</u>; seconded by Jurisprudence. A clarification regarding the definition of active duty was called. After some discussion, Companion Marvin Schendel <u>moved to amend by the insertion of the word "yearly" in last sentence when reference to dues</u>. The amendment was seconded and passed. The main motion, as amended, was passed.

The 2010-2011 Budget was presented by Companion Stanley Morrill, Grand Treasurer. He indicated that as presented, it was a deficit budget of <\$1,151>. He noted that since Resolution 2010-1 was passed, the increased revenue would make the budget manageable. Companion Morrill moved the budget be approved as presented. It was seconded and passed.

Grand Master Miles called for the Report of the Charity. The Cryptic Masons Medical Research Foundation [CMMRF] report was presented by Companion Gary Odegard. Companion Odegard gave a brief summary of the history of CMMRF and a explanation of the purpose and activities funded by the CMMRF. He relayed the statistics for Minnesota's 2009 contributions, \$1,272.50 from St Paul No 1, Minneapolis No. 2, Tyrian No. 4, Duluth No. 6, Austin No. 7, Alpha No. 8, Zabud No. 10, Central No. 14, and Red Rock No. 16 and a few miscellaneous dollars through the Grand Council. Austin No. 7 was again recognized for another year of 100% contribution. He challenged the other councils to strive for 100% participation.

Companion Odegard indicated that already in 2010 \$1,524 has been received; \$300 more that all of the previous year, and he hoped Minnesota would do even better the last six months He indicated that in past years Minnesota given in excess of \$2,000, with the highest year being 2006, when Minnesota's contribution was over \$3,000. Companion Odegard said he would stand by the exit door for companion who may wish to contribute to this worthwhile endeavor. Companion Odegard had several Awards for Members of Red Rock Council No. 16.

Grand Master Miles called forward the following companions to present them with Honorary Memberships in the Grand Council of Minnesota:

- Most Worship John Cook Grand Master of Masons had to leave early but will be presented with his certificate at an appropriate time.
- Right Puissant Lawrence Weaver General Grand Principal Conductor of the Work, Cryptic Masons International;
- Most Illustrious Companion Larry Homes Most Illustrious Grand Master, South Dakota
- Most Illustrious Companion Emory Ferguson, Past Most Illustrious Grand Master, Alabama

Grand Master Miles asked the companions for remarks. Most Illustrious Companion Holmes commented on this event filled journey to the Grand Session which involved, highway patrolmen, wind, rain, tornados, detours to eventually get to Willmar, and now he has to go home.

Grand Master Miles spoke in appreciation of the Grand Officers and the outstanding work that they had done this past year. He then made presentations to each officer present at the officer's station. Grand Organist Bill Hubbard was first. Companion Hubbard thanked all of the Past Grand Masters for the position that he has occupied since 2002. He now holds the position in all three York Rite Bodies, and looks forward to being asked to continue to serve as Organist.

Grand Arch Master Hugh Swift was next. Companion Swift was speechless. Companion Douglas Nygard, Grand Principle Conductor of the Work was next, followed by Companions Michael Denke, Gary Odegard, Stan Morrill, and Harlan Heidecker.

Companion Dexter Pehle, rose and made the following motion:

"Whereas, Stanley Morrill has served this Grand Council for many, many years and is now completing his twenty-fourth year, and will be retiring, if tradition prevails, and he's hoping. <u>I would move that this Council recognize him as Grand Recorder/Treasurer</u> <u>Emeritus.</u>"

The motion had several seconds and passed without objection with standing applause. Companion Morrill rose and gave the following remarks:

"Thank you companions; It's been an enjoyable twenty-four years. I've had many, many Grand Officers to work with that were really gung-ho, and I appreciate everyone who helped me. And if they need help, if I have any knowledge left I will be willing to pass it on to them. Thank you very much."

Grand Master Miles said we were not quite done and on behalf of the Grand Council:

"Stan, In recognition of the twenty-four years, plus your years you have served the Grand Council as Grand Illustrious Master; All the travels you have done; Your work and dedication, your love and devotion, we would like to present to you this clock as a token of your service to us. We can't thank you enough."

Companion Morrill responded:

"I want to thank you very much and it's been for years I was always handing out awards to everyone else, so for once I get one back. I Thank you very much. I hope it's set to run along time because otherwise I wouldn't have a long life" He was encouraged to not let it stop.

Right Illustrious Companion Lawrence O Weaver, Right Puissant General Grand Principal Conductor of the Work for the Grand Council Cryptic Masons International and Personal Representative of Joe Vale, Most Puissant Illustrious General Grand Master. Companion Weaver was introduced, given Grand Honors and addressed the Assembly:

"Most Illustrious Grand Master, Dias, Distinguished Guests, my companions all; It is indeed a pleasure to be with you here today. This is my second trip to Minnesota. I feel somewhat abused because I was forced to drink Scotch and smoke cigars and wane into the early hours of the morning. Everybody should be so abused. I wish to thank you for the hospitality, the friendship, the brotherly love and the courtesies you have provided the office which I hold. My wife, Mary, is attending with me and Mary's not feeling real good. but I thought I'd tell you a story about her so you might get a little idea about Mary and her somewhat sad sense of humor. I took her shopping for a dress which for some reason she felt I owed her and while she was shopping, I went outside and had a cigar, now for those that smoke cigars they know that's an hour or more. I came in and she was still shopping so I went over and told her I was going upstairs to the menswear and I went and wandered around in there and just about the time I got the clerk and went to look at a sports jacket, she showed up. And as we walked over he asked me what sized do you wear and I says a 48 regular and he looked and said why we don't try a 48 RP. Okay. So we get there and that thing fit me like it was just custom made for me. And I said what does the P stand for? He said, Portly! So I turn to Mary and I say 'Honey, isn't it wonderful how the British words are coming into our vocabulary in the apparel industry and people don't have to be insulted by referring to it as 48RF for fat and she says yes Honey that is true, but she says that isn't what it really stands for. Says what does it really stand for then? And she says 'roly poly'.

Companions I bring you greetings from Most Puissant Companion Joe Vale, the Grand Master of the General Grand Council of Cryptic Masons International and I'm sure he is the one that is missing out on a great experience here in Minnesota. I have been and still am the Representative to Minnesota and I want you to know Kevin Jones, we see about as much of him in Oregon as you see of him in Minnesota he comes out on a regular basis and participates with us in our Grand Session. It's wonderful to have somebody who I'm able to communicate with so many of the others don't have any communication at all in that program. I would encourage you if you are a Grand Representative to continue to make every effort to communicate with your representative.

I want to talk to you about a few of the items on the agenda of the General Grand Council. We have one of the, when I went on the Board, we had a meeting right afterwards, and you know I thought my agenda was full of what I thought needed to be done in General Grand and then I saw the agenda of items that we're working on and I want you to know that we have 70 or 80 items that we are trying to work at to make the General Grand the absolute most prestigious organization in all of Free Masonry. We want to serve you with the best. It takes time. It takes money and we've got challenges in

both of those areas because time goes faster than we want and money is thinner than what we want. And which reminds me I'm very pleased to see you take care of your financial situations. I know what happened in Wisconsin and I'm pleased to know that that's not going to happen here; that you do have a wonderful and bright future. And when I say wonderful and bright future. I want to talk to you a little bit about those that are knocking at the door of Free Masonry. Young Men. This current generation, it's unbelievable. Just to give you an idea about some of these men. These are young men that have most likely been raised by a single parent. They probably at one point in their lives were latch key kids. They've been lied to in the school system. They've been lied to by adults through most of their lives. They are looking for something, something, they know it's got to be there that they can be involved in that deals with truth, companionship, and brotherly love. That's why they're beating on our door. And here's the really strange thing about these young men. They want to associate with you. With you, because you are the fathers, the grandfathers, the mentors, the individuals they have not had in their lives. So understand, they're young, their bright, they have a lot of ideas. They'll listen to you and they need you to mentor them and that's your job. Bring them in and mentor them. And everywhere I go I hear the stories about how they're coming out of the woodwork. If you aren't on an internet site with a website, you think about finding somebody within your group that can do that. You'd be surprised at how many hits you'll start getting from these young guys that are looking at how do I become a York Rite Mason. Often times they are looking at specifics beyond the Blue Lodge and they don't realize they have to be Blue Lodge Masons. It's your opportunity to take care of them. But we have the opportunity. We have the opportunity. We're the first in three generations to have this opportunity - to leave a legacy in Free Masonry. It's up to you. Go do it!

Constitution and By-Laws of the General Grand Chapter. This is really boring stuff, but our Constitution was written in 1993, proposed in 1993 and passed. It was actually one before that. We have had great difficulty as the leadership of the General Grand to try to do the job with the current Constitution and By-Laws because it doesn't cover enough needed information nor is it capsulated in such a manner that we can easily do what we need to in a three-year period. If we were meeting every year like a Grand it would probably be much easier, but when we meet only in triennial sessions it's very difficult. So, what has happened is we have taken the current constitution, and we have revised that constitution, removed a lot of things within that constitution and taken them over into a bylaws section the constitution basically is to be set where it's rarely ever changed. That's the meaning of the constitution. But, when you've got something in your constitution, like a life-membership fee, that's the wrong place for it. There is so much change involved in this that we are going to be asking the companions at the triennial to revoke the current constitution and in it's place adopt the new Constitution and By-Laws. We will be sharing this information with you at the regional conferences and we will not beat you up with that information. We'll go through it. We want you to look at it. We want you to understand it. We want you to have input in to it. It will be on the web site in the near future because it's all most in the final draft. And certainly when it's sent on as legislation it will be there. So please come to the regional conferences.

And while I'm talking about regional conferences, I want to talk to the individuals of the councils themselves, the leaders that are here. Those conferences aren't just for the

Grand's, they're for you too. They're your opportunity to get some current information, some leadership information, and they're designed around the needs of the grand councils and their membership within, these what is it about seven states in this region, most of them are around that number, so I invite you to put those dates on your calendars, would encourage the Most Illustrious Grand Master to encourage the folks within each of those councils to attend if they can. What many of you might not know, the General Grand Council has for a long time been the leader in presenting leadership material and we have slipped and we're going to have to do a better job and get back up and running and take that leadership roll again. And I firmly believe we are the very best of the best right here. This is it. I have to believe that. And I have to work to make it that way and you know you've heard 90% attitude. Take on that attitude, companions. And you are the best and it will show.

Cryptic Masons Medical Research, I thank the state coordinator for CMMRF for the report and for the donations to CMRF. I just this last month was at the University of Indiana for the Board Meeting and we were presented with some information, I mean it's unbelievable what they're doing. Some of it kind of, kind of throws back the doors and you think what in the world? But they're actually looking at banking stem cells, and the first area they were looking at is when a child is born the after-birth is filled with stem cells, and they're looking at banking those or some of those for future use with that individual. And now there actually looking at women's menstrual cycles to bank stem cells. Evidently, there's loads of stem cells that are very usable in that system. So I mean they are thinking way outside the box. When it comes to me, I have difficulty just understanding taking something out of my fatty tissue or getting stem cells out of my bone marrow. As most of you might know we've had two clinical studies, approved studies, on the injection of stem cells in the legs and the stem cells actually, when they inject them, they attach themselves to the vessel and they build a new vessel around the blockage. I'm happy to report to you today, that it has been approved for this to go into a clinical situation and there are ten sites within the United States, we haven't been told what those are vet, that Dr Marks will be going out and will be training physicians in the procedure. The procedure is fairly simple, really. They put you on a table, they take bone marrow, they run it through a centrifuge, they mark all these places on your leg and down your foot and then they inject them. When you're done, you get up and walk out of the clinic and in a short period of time start having use of those limbs like you did before you had the blockages and the problems with your legs. Of all those that have went through the studies there has been 100% success and no one losing any limbs. And some of these folks that went in were scheduled, scheduled to lose limbs. There is an area that your money has gone to in research that has made major, major advancements in the medical field and its going to be benefitting folks right now, maybe even some of you. Diabetes is an area that they are working on. Interesting what they are able to do with stem cells and they are working with type 2 diabetes and I don't really understand it, it's just in the animal stages right now, but they think they have an answer to someone having to take insulin injections in the future they can use it with stem cells. Regenerate the stem cells in your pancreas. This is exciting, exciting, stuff. Vascular dementia. This is what my wife has, so I'm very familiar with the situation. They are starting to work with that. Very tough, tough situation folks when you have a loved one who has dementia. So that's what your money is going for. I'd ask you as you leave today, dig as deep as you can for our charity. It's important that we

continue to make these advancements, not necessarily for us individually, but for those that come after us, it's part of that legacy.

Corporate Foundation. I don't know that you know the corporate foundation was established in I believe '93 with \$50,000 and the \$50,000 was supposed to be irreducible but somehow or other it didn't fit into that category and got spent. Been gone for some time. General Grand Council has struggled financially for a lot of years and we're still struggling. One of the things we are trying to do is rebuild that corporate foundation, but rebuild it in such a manner as hopefully the day will come when we won't ever have to come and say folks we need some more per capita. That's our intent. So you'll see us selling things to try and build that. Some of you got the Cryptic Mason Medical Research coins or the Triennial coin. I want you to know that 71% of that goes to CMMRF. The remaining percentage is split between the George Washington Masonic Memorial Cryptic Room and the General Grand Corporate Foundation. And we thank you for your donations. I believe maybe Kevin might still have some of those coins. I'm not sure. He's got one left. So. Okay.

General Grand Office. I hope everybody's having better success with what's going on there. You're Recorder is the one that would be telling you if he was happy or unhappy with General Grand that would be because of the office, but Dave Grindle has got it up and running and is doing an excellent job with better communications going on.

Publications. We still have a lot of publications that we have available at General Grand that really need to be updated and this some of these are on that list I told you of items that we're trying to peck away at and sure enough we're getting them a few at a time, a few at a time, but it takes a lot of time, you know when you come into a job all excited, and you think I'm going to change it and we're going get it going and then the realization sets in that it's a lot of work, actually I can tell you that just on that constitution that I've spent about 14 months working on it with committee. A lot of work folks. So the Cryptic Masons Magazine, how many subscribe to the Cryptic Masons Magazine here? Okay. You can still get subscriptions. I don't have any subscriptions with me, you can get them on-line. But the news is, the spring edition of the Cryptic Masons Magazine is online. It's on-line for you to get. You do have to have a subscription to get it. They'll send you the password and so forth to get into it if you have a subscription. Our intent is to put back issues at some point on there for everybody to look at and that's another one of those "lot's of work" and you've got to find the right person to do the work. I would encourage you to subscribe to that. We actually found that we were serving less than 2% of our membership with that magazine. Less than 2%. And that's not very good communication and we're going to be working at doing better communication and we feel that through the web-site is the best way we can do that.

Regional Conferences. I spoke to you briefly about those. The per capita increase has taken place. We thank you so very, very much. The 65 cents really we haven't benefited from that at this point, but we are very close to seeing some funds available to do some of the things that we have had to put on hold.

Lady of the Council. How many wives, of your wives, have Lady of the Council? Okay, there's a few. Guys, I don't know about you, but my wife I appreciate tremendously, cause she has just been wonderful to me and when the opportunity to get her Lady of the Council came along I jumped at it and to get her recognition in front of the Grand Banquet and that's where most of them are presented, embarrassed her so that's was a good thing, anyhow it got us payback, but to get her recognition she felt really great about that knowing that folks cared enough for her to receive that. You can purchase those through General Grand, they're \$100. You can purchase that Lady of the Council for your wife and have it presented. It doesn't have to be at the Grand Banquet. You can make arrangements for any kind of presentation you want within your state but most do it at the banquet because that's where your largest numbers at. So consider that. Consider looking after your wife and thanking her for what she's done.

We spoke about the web-site and spoke to you about membership. I see some real changes happening in membership. It excites me. It excites me because these young men that are coming in they understand, they understand what further light is. They understand that when they're told they have a substitute for the ancient word, that the ancient word is still out there. So they're looking towards the York Rite to get that. So they're looking toward the Chapter and the natural from the Chapter is the Council. So you have lots of opportunity to bring good young men in. And you don't have to wait for them to ask you. They've already proven their worth by being received within their lodges. So I encourage you to set down, speak to them, work with them, and help them find the path through the York Rite which is the progression of the Blue Lodge degrees. With that my companions, I do have a couple other items here.

Life Membership. How many are aware of the General Grand Life Membership? Okay. And I'm suppose some of you have purchased those? They are \$10 at this point. Well, what does that do for you. Your Grand Council will no longer pay per capita on members who have purchased that \$10 life membership. Now here's what I want to tell you. There are some states that have purchased those for every member in their Grand Council. And that \$10 is going to at least double at the next triennial. \$10 doesn't really, really do much for us. It's we're not making money on that, were loosing at this point, but I want you to know the opportunity is still there to get those for \$10 and I'll leave those, some applications here on your secretaries desk. There's also applications for the two volume The History of the Cryptic Rite. How many have seen the Hostory of the Cryptic Rite? Have any of you looked on line and seen what that sells for on e-bay? Considerable. I've seen them go as high as \$400 for that two volume set. We really want to republish that. But we don't have the funds to do that without the commitment from you. So what I'm going to do is I'm going to leave this it's a special offer that 2-set would cost you a \$100. And it's not out of your pocket today. If you sign up for it and send it into the General Grand Recorder, when we get enough that we could generate the funds to print that, then we will do that. So if you're interested they are here, also on the recorders desk.

Companions, again I thank you so very much. I feel such a part of Minnesota. You've treated me so well and you've treated me in so many different ways, I've had to like some of them. And so with that I want to say God Bless you. Remember, remember, that the Sacred Volume of the Law is where we really get everything that we are looking

for. So study the sacred law, be true to each other, enjoy your fellowship, remember brotherly love, truth and relief, and with that I thank you and God Bless you."

# INSTALLATION OF IGM RONALD A. MILES July 13, 2009

The Jurisprudence Committee of the Grand Council of Cryptic Masons of Minnesota met at the home of RIC Ronald A. # HOLDING COUNCIL.

# SubSection .01 HOW FORMED

The Holding Council known as *Grand Master Hiram* Council No. 13 UD, shall be formed by the granting of a dispensation to said Council No. 13 UD each year by the Most Illustrious Grand Master, in order that all rules and laws of the Grand Council would be complied with.

# SubSection . 02 MEMBERSHIP

Membership shall be limited to Companions of constituent Minnesota Councils which have lost or surrendered their charters, or who demitted when their council ceased to exist. It is open to any companion who demitted or withdrew or was suspended from a merged or consolidated council. Petitions for Affiliation are acceptable when accompanied with a certificate of Good Standing. Dual membership within Minnesota is prohibited

# SubSection .03 PROPERTY, RECORDS & FINANCES

All assets, property and records of any closed Council shall become the property of the *Grand Master Hiram* Council No. 13 UD. Revenues are derived from the dues of the members. Dues cards with the name *Grand Master Hiram* Council No. 13 UD and their previous Council would be issued from *Grand Master Hiram* Council No. 13 UD, using the same dues structure as their previous Council. Life Memberships shall be available based on the applicant's previous Council's dues structure. Dues notices and the collection of the dues shall by accomplished by the Grand Recorder/ Treasurer. Demitted members seeking membership shall become members by application and the paying of the current year's dues. Members suspended for Non-Payment may restore membership upon application and payment of one and one-half times (1 & 1/2) current dues.

# SubSection .04 OFFICERS & MEETINGS

The Officers of this Holding Council shall only be the Grand Council Officers for each year, who will retain their membership in their home Council and not pay dues to *Grand Master Hiram* Council No. 13 UD . The Grand Recorder/Treasurer shall be retained as a permanent officer of the Holding Council. The Annual Meeting will be held during the Grand Assembly session each year.
