I was unable to attend the Grand Sessions of Nebraska, Wisconsin, or Iowa. Grand Officer and committee meetings were held at regular intervals. Some dates had to be shifted to accommodate other events that we were all involved in.

Several challenges arose during this year. The Dias Officers, Grand Recorder and Jurisprudence Committee Officers were immediately consulted and were in the loop every step of the way. I cannot say enough about these Sir Knights. They handled these challenges with decorum and professionalism.

The following General Orders and Dispensations were given by my hand.

- 1. General orders 1-115 were sent for dissemination to the constituent commanderies and Sir Knights and will not be listed here. They are available on the Grand Commandery website.
- 2. Dispensation was granted to the Membership Committee Chair to add participants to this committee as he deems necessary.
- 3. Dispensation was granted to Palestine Commandery #14 to move to their new Lodge building in Underwood. Charter to be moved as well.
- 4. Dispensation was granted for Minneapolis Mounted Commandery #23 to move their stated conclave to the Zuhrah Horseman's ranch.
- 5. Dispensation was granted to Duluth Commandery #18 to move their stated meeting from November 1st to November18th, with proper notification to the Sir Knights.
- 6. Dispensation was granted to Zion Commandery #2 to start their stated Conclave at 6:30 instead of 7pm for the purpose of presenting the Order of the Red Cross and Malta with proper notification of the Sir Knights.
- 7. Dispensation was granted to Faribault Commandery #8 to move their stated conclave to Zion Commandery #2 on 10/24/2022 with proper notification of the Sir Knight and having their charter present.
- 8. Dispensation was granted to SK Clint Christensen to knight a knight of Malta, because he had to leave the Commandery Festival 15 minutes early.
- 9. Dispensation was granted to Faribault Commandery #8 to move their Stated Conclave of December 26th, 2022, to December 19th, 2022. This is to avoid conflicts with Christmas celebrations and SK's being out of town for Christmas on the 26th. Proper notification will be given to the Sir Knights.
- 10. Dispensation was granted to Damascus Commandery #1 to move their stated Conclave from Feb 14th to Feb 28th with proper notification of the Sir Knights because of Valentines day.
- 11. Dispensation was granted on Feb 16th to Ivanhoe Commandery #31 to hold their election of officers outside of their normal timeframe. This was requested by SK Sean Gardiner PGC.





- 12. Dispensation was granted to Home Commandery #5 for them to move their annual meeting from April to December.
- 13. Dispensation was granted to Palestine Commandery #14 to move it's stated conclave from April 13th to April 20th, with proper notice to the Sir Knights, because of a conflict with Grand Lodge attendance.

I wish to thank the officers and committee members of this Grand Commandery for their dedication, diligence, and willingness to go the extra mile in support of the Grand Commandery and constituent Commanderies of MN. I am proud of all of you.


The text details the:

All this was always in the presence of witnesses.

Part of the pardon language given to de Molay thusly reads:

"After this, we concluded to extend the mercy of pardons for these acts to Brother Jacques de Molay, the Grandmaster of the said Order, who in the form and manner described above had denounced in our presence the described and any other heresy, and swore in person on the Lord's Holy Gospel, and humbly asked for the mercy of pardon [from excommunication], restoring him to unity with the Church and reinstating him to the communion of the faithful and the sacraments of the Church." It appears final acceptance of the language and the corresponding measures may have been subject to consent of the King to enact.

A potential olive branch as this certainly bears mention in annual report, as it may also turn out to be worthy of due consideration, whereby we may stand to learn more about 'who' actually articulated the levers of demise. If this document stands true, then we learned more about the 1st twelve months of de Molay's seven-year captivity.

RE: Committee on Jurisprudence annual report for the Templar year of 2022-2023

Sir Knights All,

On behalf of Sir Knights Sean Gardiner and Todd Jovonovich, I submit the summarized activities of the Committee on Jurisprudence for 2022-2023 were as follows:

- In late August, the Committee on Jurisprudence was tasked with review of the General Orders of the Right Eminent Grand Commander to confirm compliance with Templar law, which was affirmed.
- On August 24, 2022, the Chair was asked to review and comment on the application of Section 45 governing Grand Officer Adherence to Duties, specifically regarding Grand Officer attendance.
- On September 22, 2022, the Chair was tasked with ascertaining the legality, practicality, and procedure to establish a constitutional committee of elected trustees. The Chair conferred with Grand Encampment's Committee on Jurisprudence, as summarized,

The interplay between sections 43 (GC Officers) and 48(b) (Powers of the Grand Commander). You are correct that section 43 prohibits a Grand Commandery from having any constitutional officers others than those enumerated in this section.

Section 48(b), however, grants the Grand Commander power to appoint all Committees not made elective, and to fill all vacancies, such appointees to serve during his pleasure or until their successors have been elected or appointed an installed. This clearly implies that elected committeemen are permissible. In effect, viewing the proposed trustees as elected committeemen and not as constitutional officers.

Many Grand Commanderies have elected trustees to manage their various funds and I applaud REGC David for contemplating this step. One scenario, as you mentioned, would be to have three trustees with staggered terms so one is elected every year thus providing continuity and institutional memory among the trustees. This could be





established by having the first trustees serve one, two, and three year terms and then three years thereafter. You would also want to specify which funds the trustees are responsible for managing, e.g. Educational, Holy Land Pilgrimage, Life Membership, Endowment or Reserve, Triennial, etc.

- On October 16, 2022, the Committee was asked to review if a constituent Commandery must submit a bylaws change to Jurisprudence for review if the only change was to its annual calendar year to bring the constituent Commandery in accordance with the change made to the Grand Commandery Constitution in June 2022. It was ruled that due the change of the Grand Commandery calendar, unchanged constituent Commandery calendars became irregular. However, due to the nature of their recognition by the Grand Commandery, the bylaws changes of the calendar are germane and an action taken to remain in constitutional compliance with the Grand Commandery. Such action is granted/grandfathered to ensure compliance with Grand Commandery of Minnesota, and constituent bylaws regarding this issue may be changed and immediately adopted without further delay.
- On November 19, 2022, the Committee ruled on a question regarding the usage of funds from
 the Benevolence Committee for the payment of per capita to the Grand Encampment caused
 generally by shortfalls from the life membership fund and members in arrears. As it was not an
 individual member that required relief, nor applied for such, it was ruled that such use of the
 Benevolence Committee funds would violate the MNGCKT Constitution.
- Additionally in November 2022, the Chair assisted Faribault Commandery with review of proposed changes of their bylaws to ensure compliance with the Constitutions of the Grand Commandery of Minnesota and the Grand Encampment of Knights Templar, USA.
- On February 15, 2023, the Chair completed tasking for the reorganization of the Constitution,
 Laws, Rules, and Regulations of the Grand Commandery of Minnesota. The changes made to the
 document were all housekeeping measures, recategorization, and addition of a statute-style
 numerical system for all items enshrined in our formation document. As changes were germane
 without impacting, adding, altering, or removing any components of the Constitution, those
 changes may be implemented at will by the Grand Commandery in the future.
- On February 17, 2023, due to a potential conflict of interest the Chair recused himself from the Committee on Jurisprudence regarding a matter that had come before the Grand Commandery. Sir Knight Sean Gardiner was appointed Chair pro tem, with Sir Knight Joel Porter joining the Committee for the duration of the proceedings of the event in question. The concern had passed without the Grand Commandery having to take any official action(s), and the Committee on Jurisprudence was not called on to adjudicate any questions arising from the matter. Sir





Knight Helcl was reinstated as Chair of the Committee, and Sir Knight Porter dismissed from the Committee in good standing.

The Jurisprudence Committee was not called upon further by the Grand Commander to meet to adjudicate any questions regarding any legislative, judicial and executive functions of the Grand Commandery and the constituent Commanderies and on the prerogatives, powers and duties of the officers and members thereof during this Commandery year.

Nothing to report further from the Committee.

The Membership Committee started strong this year. We have met several times and began early working on several items. We divided the Commanderies between the Committee members giving us all three to work with. We then began discovering who the Constituent Commandery Membership Chairmen were so that they could be our direct contact. Our intention was to make clear that while the committee cannot directly recruit new Sir Knights to their Commanderies, we can provide the support in "marketing materials" that they can use to do so. We discussed visiting Lodges to make presentations. We also attempted to obtain Templar tri-fold brochures from Grand Encampment.

While we were ambitious to get these several tasks completed, we were overly optimistic on the speed at which this Templar machine runs. Presentation materials were not as easily obtainable as we had hoped, Commanderies were slow to appoint their Membership Chairman, and we are still waiting on responses for pamphlets and trifolds for Templar presentations.

We discovered that the member information in the MMS system used to manage our membership is often incorrect. We need to encourage our Recorders to verify that the information currently in the system as well as new information for the future is updated regularly.

Two of us from the Committee attended the Grand Lodge Membership Summit in March. There were excellent presentations and helpful information for all Masonic bodies to utilize and take away.

Recruiting from the last York Rite Body is difficult if we have no Membership Committee at the Grand Chapter or Grand Council level. We have discussed the necessity of having a Membership Committee at both of those levels if we wish to recruit new Masons to become, ultimately, Knights Templar. We simply can't do the recruiting for the whole of the York Rite at the Grand Commandery level.

If we want the York Rite in Minnesota to succeed, we need to start working as one cohesive unit from a membership perspective.

I wish to thank the members of this Committee and to the Sir Knights of this jurisdiction for their commitment and support.
