

Report of the Most Illustrious Grand Master Brian K. Dimatteo 2022 to 2023

To: The Grand Offices and Companions of Grand Council of Cryptic Masons of Minnesota.

From: MIC Brian K. Dimatteo, Illustrious Grand Master, Grand Council of Cryptic Masons of Minnesota

My Companions, I bring you greetings!

As I think back on the past seven years, and even prior to that, I am able to smile. When I was appointed to this progressive line, I was honored, and I knew it was going to be an amazing ride, but I don't think I had any idea of the scope of that time. I knew that there was a lot to be done and I felt that I was up to that task, so when I said "yes" when I was asked, I was "ready". Little did I know what exactly would be required of me.

I have had the honor of serving not only our Grand Council but other bodies in our Fraternity over the years. I look at the times we have all endured over the past ten years, and I think that few Freemasons in the future will have to go through similar. It's not lost on me that others have probably had the same feelings. Our Brothers in the 1800s, the late 20s, the 40s, 70s all likely felt the same things. Those that come after us all will have similar thoughts as THEY remark on their time in the Craft.

I want to start off with a few thanks for those important people in my life and along this journey. To MIC Marvin Schendel – the work of this Council would be impossible without your countless hours and dedication. You have been a model for me, and for others, about what "Servant Leadership" should entail. To MIC W. David Emery – you preceded me in this journey, and you, likewise have served with honor and distinction, giving advice but more so, being the steady hand on the reins. To James McNeely, whom we affectionally call IV, you did me the honor of Installing me a year ago. You are a fountain of knowledge in Freemasonry, and I am Honored to call you friend, companion and Brother.

To the officers of the Grand Council – you have spent hours, days, miles in serving our Councils and this Grand Council. You have spent time away from your families and jobs, and the work that you have done is exemplary. Congratulations and thank you to all of you for what you have done and will continue to do. I would be remiss if I didn't call out my thanks to Roberto Sean Gardiner – someone who I worked with in the Grand Commandery line, who appointed me to the Grand Chapter line. I thank you for your friendship and Brotherhood. Finally, to Jim Luchsinger for everything and every recognition and piece of advice you have given to me. There are few men that I hold in as high regard as I do you. Thank you. My Companions, I want to spend a few moments to talk about our Youth organizations. As many of you know, I am extremely active with our Job's Daughters, and am starting to finally get a chance to be involved with DeMolay. Our youth are at a critical impasse right now. How many of you know that we are to the point where, if things don't change, we will lose our Grand Bethel and autonomy to the Supreme Council of Job's Daughters? Similarly, we are to the point where in a year, we may install our LAST Grand Guardian (the female titular adult leader)? While DeMolay are growing, they have similar challenges at the local Chapters as well. We have issues and challenges not only in getting youth, but also getting adult volunteers. There are any number of explanations / excuses why someone cannot help the youth. My Companions, it doesn't have to be a huge amount of time spent working with them, although, none of us would turn you away, but it can be as simple as going to one meeting a term. Believe me when I say that they stand a bit straighter, speak a bit slower and move a bit more deliberately when they see their Uncles in the audience.

This year I have instituted a program for the Jobs Daughters to help them grow, and was able to use some of the Grand Master's stipend not just for my own travel, but in support of this beautiful Order. If you have a chance, please reach out to your local Bethel or Chapter, or if you have a mind to help found a new one at your Lodge, contact either me or Aaron Brendel for DeMolay. You won't be sorry for any moment you get to spend with these amazing young men and women.

Our Premier philanthropy, the Cryptic Masons Medical Research fund also needs your help. We, in Minnesota, have a strong history of supporting this great charity. As past Grand Masters have shared, as have our deputies, it is one of the only charities that focuses on Men at our age. They quite often, at Department conferences, start with everyone standing and then seat those who have PAD, Diabetes, etc. And by the time they get to the end of the diseases that we study and attempt to cure, there are very few people left standing. Please consider giving and giving generously to this great organization.

A year ago, there was a challenge to this Grand Council that happened, not in our Assemblies, but in our Commanderies. There was a resolution at the Grand Commandery to remove the Council as a requirement for entry. This was defeated, but it is a concern for your Grand Officers, and for your Councils. The inclusion of our beautiful Ritual as a precursor for Commandery Orders is not about forcing people into the Council as a stepping stone to Commandery. The inclusion of the Council as a requirement of Commandery is more, at least to me, about a completion of our York Rite Degrees and Orders. We would not take out Chapter or Blue Lodge as a requirement for membership, any more than you would exclude your brother Hank from Christmas Dinner with your family.

You may have noticed that above, I talked about service. I want to reiterate that it is not the title that drew me, or that should draw you to lead a Chapter, a Council or Commandery, whether local of at the state level. We serve our Companions and Sir Knights. We serve our communities, our families, our Lodges. We serve something larger than ourselves when we take on these roles. I want to thank our Illustrious Masters for their service to our Councils and to our Craft in general. You are the reasons why we are able to continue with our good works, and your service is critical. I have often heard people complain that we "can't expect every officer to be at all the meetings. After all, this is a voluntary organization". My companions, this is true, but only to a point. It is truly a volunteer organization up to the point where you take the obligation at the altar in the installation ceremonies. It doesn't matter if it is a local Council, or this Grand Council or the General Grand level. When you accept the officer's position, you have gone from a voluntary participant to participating in the job, the business, of leading a Council. I urge you to remember this as you face the decision on whether to serve or not. The benefits gained are numerous, but the work can be difficult, long hours, many miles of travel or sleepless nights.

Finally, if you thought I would forget my family, you are mistaken. They have given up time with me, allowing me to go out and "Play" at Freemasonry. They have all supported me in my Masonic activities. I cam to our Fraternity later in life, as a first generation Mason. They have learned along side of me what it means to be a Mason. To my daughters, Frani and Gabbi, you will never really know how proud of you I am. Your time in Jobies, your coming to my events and helping serve food, or clean Lodge, or any number of other things. Thank you to my little girls who have become outstanding young women. To my wife, Wendy. I could fill pages with the things that she has done for me over the years. She has stood by me, traveled with me, met and talked with my friends, Brothers, their ladies. She has endured being called "Lady" even though she would tell me often, she's not a Lady, she's a "Broad". What ever title she bears, the one that I value most is my love. Thank you for everything you do not only for me, but for our Gentle Craft, for our Job's Daughters, and everyone you touch.

Companions, the hours are short, but the days are long. These few words can never express the truth any better. As this year comes to a close, I look forward to continuing in my service to the Craft and our Council. I thank you for spending some time reading just these few words. I promise you I won't read this word for word at our Assembly. I wish you all the best, and know that you have all touched me deeply and have a lasting part in my life.

Report of the Trustees

Report of the Trustees, 2022 – 2023

To: The Most Illustrious Grand Master, Officers and Members of the Grand Council of Cryptic Masons of Minnesota.

It has been with great pleasure to serve our officers and members of the Grand Council of Cryptic Masons of Minnesota as your Trustees. 2022 – 2023 completes a 12 year service to the Grand Council of Cryptic Masons of Minnesota. We sincerely hope that your Grand Council Officers and membership of the respective Councils of Cryptic Masons in Minnesota have found value in the work your Trustees have done for you since we began in 2012. The Trustees communicated throughout the year serving the needs of Grand Offices, attending Grand Officers' meetings, Cryptic Rite Medical Research Fund, our Councils of Cryptic Masons in Minnesota, and Grand Council of Cryptic Masons finances and investments. On the investment side of your Grand Council: January 1, 2022 Investment Fund Value: \$70,593.48 June 30, 2022 Investment Fund Value: \$60,357.70 December 31, 2022 Investment Fund Value: \$62,025.51 March 31, 2023 Investment Fund Value: \$63,606.69 January 1, 2022 Life Membership Fund Value: \$60,145.65 June 30, 2022 Life Membership Fund Value: \$52,345.20 December 31, 2022 Life Membership Fund Value: \$53,788.52 March 31, 2023 Life Membership Fund Value: \$57,417.76 One life membership was added in 2022 which raised our Life Membership portion of our total investment fund from 85.20% to 86.72%. In 2014 our Life Membership portion of our total Investment fund was 75.5%. So far in 2023, two new life memberships have been added that increased our Life Membership portion 90.22%. Life membership increases do draw down the total investment reserves to 9.78% for our Grand Council. As of March 31,2023, this amount is \$6,188.93. I have advised our Grand Officers to consider adding to the investment fund to increase their reserve funds. Operating funds cannot be drawn from the Life Membership portion of the total investment fund.

Our rate of return for 2022 is 3.67%, up from 2.79% in 2021. 2022 resulted in \$1,976.49 allocation for our subordinate Councils for their Life Membership per capita.

Correction from last year's Trustees report. It was reported a total of \$23,013.73 were distributed for the past 8 years, the correct amount is \$20,312.97.

For the past 9 years \$22,289.46 was distributed with an average rate of return of 4.48% and average distribution of \$2,476.61.

This past year was good to get back into a normal mode , I want to thank the Grand Offices and the Companion Recorders, for all their help and hard work this year. The Minnesota Recorders are: St Paul – Peter Laudert, Minneapolis – Joe Anderson, Ark – Steven Partridge, Tyrian – Ben Mahlkie, Duluth – Alan Mackenzie, Austin – John Fair, Alpha – David Dumonceaux, Omega – Carl Lidstrom, Zabud – Brian K. Dimatteo, Northfield – Jerry Zierdt, Central – Matthew Lauters.

The job of Recorder involves more than just taking minutes and reports, it is tracking all the members. The Recorder does a lot of work behind the scenes to make your Council work, anything that you can do to help your Recorder is greatly appreciated by them and myself.

The 2023 – 2024 Budget shows very little change from the previous year and is a balanced budget. Your Grand Council is working to keep expenses down while providing for all the necessary tools that are needed by both the Grand Council and the Constituent Councils of Minnesota. We are asking for an increase in the per capita. The last time it was increased was in 2016.

We are investigating upgrading our database to MMS, we will need to have funds to pay for the cost of input and annual charges. The benefits are that all the changes will be done at the local level, Companions can make changes to their information as needed and there will be no need to have quarterly reports or annual reports done, as they will be available right from the MMS database. At the end of the year a simple download and a per capita bill can be issued to each Council, no need to have the time consuming reports done, and it will make the job easier for all of the recorders. With MMS the information only has to be entered into the system once and all three, Chapter, Council, and Commandery are updated. These are some of the advantages of upgrading the database.

This last year the Grand Council saw an **increase** in membership of **3% Tyrian Council showed a 12% increase**, **St Paul 10%**, **Minneapolis 6%**, and **Zabud 4%**, we had several Councils break even with no change. Great Work Companions.

CMMRF report Diseases on Which the Indiana Center for Vascular Biology and Medicine Is Focusing

2023 Update

1. Peripheral Arterial disease.

a. PAD is a greater health care burden than coronary artery disease in the U.S.

Approximately 8 million Americans are afflicted with PAD.

b. Critical limb threatening ischemia, (CLTI), is the most severe form of PAD and is characterized by foot pain and gangrene. CLTI is a significant risk for amputation of the leg and has a quality of life equivalent to terminal cancer.

c. Surgical interventions have provided excellent results in treating CLTI however up to 30% of patients with CLTI will not be candidates for angioplasty or bypass and the only treatment option for relief of pain or removal of an infected ulcer is amputation. Over 153,000 amputations are performed each year ranking as the 6th costliest operation at 10.6-billion-dollar expense to our health care system.

d. Diabetic patients are especially at risk for limb amputation due to infection and more extensive hardening of the arteries. The incidence of diabetes and its vascular

complications continues to rise each year.

e. The American Heart Association has recently noted that amputations due to PAD and diabetes has increased over the past ten years. The AHA issued a policy statement that there needs to be an international effort to reduce amputations by 20% by the year 2030.

f. With the support of the CMMRF the ICVBM is addressing the critical need for effective therapies to prevent amputations and has been a recognized international leader in this field. g. With research funds we have created a diabetic mouse model of CLTI and we are testing new cell types and preparations

h. Dr. Stephen Miller, PhD., has discovered that mesenchymal1 stem cells grown in clusters, called spheroids, are able to regenerate skeletal muscle in the diabetic mice with limb ischemia. More excitingly, we have found that those mice treated with MSC spheroids have complete return of muscle function and limb function. Thus, a discovery that we plan to quickly translate into a clinical trial.

i. We are collaborating with Dr. David Mooney from Harvard University who has developed a gel material that can envelope the stem cell and then be injected into the muscle of a leg with PAD. In addition, with the Mason's research funds, we have purchased the Buchi Encapsulator. This device encapsulates cells 2 which protects them from getting cleared by the recipient's immune system yet still allows the cells to secrete growth factors that stimulate new blood vessels to grow.

o. Update: The ICVBM has been awarded a \$2.4 million grant to assess the safety and feasibility of using MSCs derived from induced pluripotent stem cells in a

Phase I clinical trial that will treat 20 veterans with diabetes and CTLI. This will be the first time iPSC-MSCs will be used to treat cardiovascular disease.

p. We are now using induced pluripotent stem cells that have been genetically

Report of the Grand Principal Conductor of the Work

To: The Most Illustrious Grand Master, Grand Officers and Members of the Grand Council of Cryptic Masons of Minnesota:

Since my appointment as the Grand Principal Conductor of the Work of the Grand Council of Cryptic Masons of Minnesota for 2022 - 2023, I have attended nearly all of the Grand Officer's meetings, and other Council and York Rite events. In addition, I served as the Area Representative for Zabud Council and have attended many of their stated meetings.

I was assigned to a number of committees this past year I have chosen to report on the following:

York Rite Grand Representative Program committee consists of MEC L. Greg Schultz and myself. Over the past several years MEC Greg and I have developed a Grand Representatives program that fulfills the needs of our York Rite bodies and should, with some minor adjustments, be suitable for any York Rite body. As with most activities, Covid-19 caused significant delays in our progress. The good news is that the York Rite Grand Representatives Program draft is complete. During the first quarter of 2023 we submitted our proposed program to the General Grand Council for review and approval. As of March 2023, we have not received a verdict, however, their initial impression appears to have been favorable. We look forward to getting the Grand Representatives program fully implemented in the upcoming year.

York Rite Emissary Program is a developing program. The basic foundation and guidelines for the program are set. As of March 2023, we have nine Companions that have volunteered to take on the role of Emissary for their Lodge. Once we have received a few more volunteers we will begin our training program. Currently there are 124 lodges in the state, but not all of them are active. The goal of the York Rite Emissary Program is to place an Emissary in each active lodge. The function of the Emissary is to keep their lodge informed of York Rite activities and events.

York Rite Education Committee has been active on a limited basis for the past several years. We had been making good progress until the onset of Covid-19. We are now in the process of reactivating and reinvigorating our education program across the York Rite. One of our ongoing goals has been to make educational materials easily available to all of our members. A goal for the upcoming year is to make additional educational materials available and downloadable from our websites. This will allow easy access to interesting and informative presentations. To add value for our members, every York Rite body should make education part of every meeting. We are always seeking volunteers to assist the Education Committee in building our library and presenting educational programs. Please consider volunteering.

Other Activities:

2023 Statewide (Masonic) Membership Conference, held at the Minneapolis Scottish Rite on March 25, 2023. SK James Henderson and I represented the York Rite at the conference, and we talked to a number of Masons about joining the York Rite. Compared to other Masonic bodies we had a rather poor showing. After speaking with the conference coordinator Br. David Hartman, I found out that no one from the York Rite had RSVP'd or signed us up for a table. With Br. Hartmann's help we found a table. SK Jim and I were able to scrounge up some items for a display, but it was meager when compared to the other bodies present. We had no backdrops (pull out signage), and few supplies. With the help of C Larry Stelmach, and SK Clint Christianson we were able to make a showing. Overall, the conference was very successful, the speakers were all very good and many very good ideas were put forth. I would estimate that there were nearly one hundred people in attendance.

The biggest takeaway for me was that we must establish a **York Rite Membership Committee** composed of members from each of the four bodies, with a Chairman, Function Coordinator, Equipment Manager, and Spokesmen. Our poor showing at the Membership Conference and other Masonic functions is directly attributable to the fact that no one was in charge, or accountable. We just showed up and that must change! Membership functions, events and other activities must be addressed at every York Rite joint meeting. To emphasize the importance of this committee I would recommend that each of the three Deputies be on this committee with one of them assigned as the Chair and one as the Function Coordinator.

The **Grand Council Strategic Planning Meeting** was held on April 2, at the Minnesota Masonic Home in the York Rite offices. The meeting was a very informative and helpful get-together. During the meeting the grand officers determined a number of traits and factors that contribute to successful organizations. The planning session started us on a path towards developing goals and objectives for the upcoming year and for the future. As well as some of the milestones needed to attain our objectives. It was agreed by all present to hold follow-op planning meetings after our annual Grand Session to continue the process.

I anticipate that next year will continue to be a time of rebuilding and reenergizing our Councils and the York Rite at all levels. I am very much looking forward to getting out and visiting our Councils and participating in all of our York Rite activities.

James 0. Burlingame, Sr. - The Mason

John W. Burlingame, Jim's dad, became a Master Mason on April 27, 1953, and soon after encouraged his son to sign a petition for Plymouth Lodge #160. So, on May 18th Jim's petition was received by the Lodge. He was then investigated, and on August 3rd he was elected to receive the Degrees of the Lodge. Jim was initiated on September 14, 1953, passed on September 28, 1953 and raised to the sublime degree of a Master Mason on October 12, 1953. Since then, he has led an exemplary, Masonic life as a Speculative Mason. He, like his father before him, encouraged his son to petition the Lodge, and on August 7, 1976, James 0. Burlingame, Jr. became a Master Mason in Plymouth Lodge #160.

Jim, Sr. was appointed to the "line" in the early 70's, and in 1978 he was elected to be Worshipful Master of Plymouth Lodge; just one year after his father had gone to the Celestial Lodge above. Jim continued to be active in the Lodge and Masonry, and in 1987 he was appointed Grand Standard Bearer in the Minnesota Grand Lodge. In 1990 he was named Minnesota Mason of the Year, and again in 1994 he received that same honor. In 1999 Plymouth Lodge gave him the highest, Blue Lodge honor by presenting him with lodge's Hiram Award. In 2004 Jim was

appointed Grand Chaplain, and in 2008 he was appointed Grand Tyler in the Minnesota Grand Lodge, serving in each station for one year.

In June, 1993, Jim became Chaplain in Plymouth Lodge #160, and be served faithfully in that office until he retired after the 2012 year. He officiated at many, many Masonic services.

Jim and bis lady Barbara moved to the Northridge Senior Apartments, and the Grand Master,

MWB David E. Olson and the Grand Secretary WB Douglas J. Campbell joined Jim and a few other Past Masters at the apartments for lunch. Following lunch, the Grand Master presented Jim with a pin and certificate

It's very easy to see that a lot has changed at the Minneapolis Scottish Rite since Jim Burlingame Sr. joined the Valley with the fall class in 1972. Perhaps the biggest change is that the Rite discovered one of the most dedicated and devoted Masons who had ever crossed the threshold of the building on Dupont Avenue.

By the time he joined the Scottish Rite, Jim bad already served the Grand Council of Cryptic Masons of Minnesota as the Grand Illustrious Master in 1970. And he was only a couple of years away from serving the Grand Chapter of Royal Arch Masons as the Grand High Priest in 1974. Invested by the Supreme Council with the Rank and Decoration of a Knight Commander of the Court of Honor in 1977, the words on Jim's lips must have been the infamous "I wish to proceed". In the coming years, Jim would act, direct and lead at the Scottish Rite and in 1988, he was installed as Commander of Kadosh for the Minneapolis Scottish Rite. Jim served a two year term as the Commander.

And then things got busy. In 1989, Jim served as the Potentate for Zuhrah Shrine, and was Coroneted a 33° Inspector General Honorary by the Supreme Council. From 1995 through 2006, Jim served the Red Cross of Constantine as Intendant General for the Minnesota Division, the highest officer in the State of Minnesota for the Red Cross.

In all his labors in Masonry, Jim saw a lot to rejoice in, and a lot that still needed work. Through his words, acts and actions, Jim set a tone that encouraged others to work together and enjoy Masonry. In 2003 when he was appointed Personal Representative to the SGIG for the Minneapolis Valley, Jim re- enforced those values, calling Minneapolis "The Happy Valley".

In 2007, the Supreme Council chose to honor James O. Burlingame Sr. by awarding him the highest individual honor it can bestow, that of the Grand Cross Court of Honor. Currently only about 77 Scottish Rite Masons in the Southern Jurisdiction of the Ancient and Accepted Scottish Rite are members of the Court. Among them are United States Senators, celebrities, and our own Jim Sr. A true testament indeed to one of the most dedicated and devoted Masons who had every crossed the threshold of a Masonic Lodge.

If we were to build a Mount Rushmore of Masonry in Minnesota, one of the faces hewn in stone would be that of James 0. Burlingame, Sr. 33°, Grand Cross Court of Honor. From the Happy Valley, thank you, Jim. Congratulations on starting the next page in the long story of your service to Masonry.

Stanley D. Morrill, 98, of Fergus Falls, died Friday, May 19, 2023 at LB Broen Home in Fergus Falls. Stanley Dwight Morrill was born on July 6, 1924 to Harvey D. and Alice (Wahlgren) Morrill in Fergus Falls, Minnesota. He was baptized and confirmed in the Augustana Church in Fergus Falls and has been a lifelong member.

He attended the old Jefferson School and the old Fergus Falls High School graduating in 1942. He worked on the Alaska Highway from July 1942 until June of 1943. After returning to Fergus Falls, he enlisted in the U.S. Navy serving 28 months being discharged on December 7, 1945. He attended North Dakota Agricultural College and earned a B.S. in Civil Engineering in 1954.

He served as presiding officer in three state Masonic Bodies: Grand High Priest of the Grand Chapter of Royal Arch Masons, 1992 Most Illustrious Grand Master of the Grand Council of Cryptic Masons, 1988 and Grand Commander of the Grand Commandery of Knights Templar of Minnesota, 1983. He also served many years as Grand Recorder of the Grand Council of Cryptic Masons of Minnesota.

He served three years as Deputy General Grand Master, North Central Region of the General Grand Council of Cryptic Masons International as well as three other appointments for the General Grand Council.

He was active in the local Masonic Bodies serving for many years as Secretary and/or Recorder as well as Secretary of Golden Rod Chapter #61 Order of the Eastern Star.

He was a member of the Disabled American Veterans and served as Department Commander of the Department of Minnesota in 1992-1993.
