It has been my great Honor and Privilege to serve the Grand Commandery of Knights Templar of Minnesota and its Sir Knights as your Grand Commander for the 2024/2025 Commandery year. In that role, I have been greatly assisted by an excellent corps of officers, and I thank them most graciously. I need to extend a very special thanks to PGC SK Alan Mackenzie for stepping into the role of Grand Recorder and doing his best not to let me stray too far off course. I have enjoyed representing our Grand Commandery at many asylums around Minnesota and the North Central Department, as well as





at several DeMolay and Jobs Daughters' events. I have continued to travel throughout the state, visiting most of our constituent Commanderies, in many cases more than once. The friendly greetings and warm hospitality extended by all is greatly appreciated. I have participated in several Commandery Orders with our constituent commanderies, their officer installations and other events.

While my journey through the officer line has not been without challenge and regrettable action, I am proud to have served. At the beginning of my term, I had laid out several goals and objectives for us to accomplish, and while all have been addressed, not all have been satisfactorily accomplished. However, I am happy to say that work will continue on the completion of some while others have been revised and will continue in a new format. We will continue to work with several of our struggling commanderies to keep them in the fold, whether through reinvigorating their members or through mergers and consolidation. However, I believe that one of our top priorities is the high percentage of demits and NPDs. Are we doing a thorough enough job of screening our applicants? Being a Companion of a Royal Arch Chapter or of a Cryptic Council should not automatically qualify one for our orders. We need to make sure that they are truly interested and willing to conform to our standards. I am also pleased to report that, through the efforts of Past Commanders, SK David Dumonceaux and SK Alan Mackenzie, our revised, revised, and revised tactics manual is available for downloading and printing.

Not all my travels have been strictly work related, but I have enjoyed traveling to several of our constituent Commanderies to participate in their Christmas and Easter observances, installation of officers and special events. The continued tradition of special events to celebrate our Christian beliefs for Christmas, Easter and Ascension is important to our Order.

We all know that we have here on earth only a temporary home and that sooner or later we must pass to our eternal home. We were reminded of that fact during this Commandery year with the passing of two of our Past Commanders. SK Forrest A. RE: Report of the Grand Captain General for 2024-2025

Sir Knights All,

As Grand Captain General of the Grand Commandery of Minnesota, I submit this summarized report of activities of that Office for the Templar year of 2024-2025:

- Grand Encampment Activities and Duties:
 - o Grand Encampment 69th Triennial Conclave- Salt Lake City, Utah.
 - I had the opportunity to attend the 69th Triennial of the Grand Encampment of Knights Templar on behalf of the Sir Knights of Minnesota as a voting delegate, performing that sacred duty by directly representing the interests and concerns of our Sir Knights, whose opinions I had proactively collected prior to the Triennial Conclave.
 - Additionally, I was given the distinct honor and privilege to be appointed as the Grand Master's Banner Bearer and Aide-de-Camp for the 70th Triennial in service to Sir Knight David Kussman, Most Eminent Grand Master of the Grand Encampment.
 - North Central Department Conference
 - In October I attended the North Central Department Conference of the Grand Encampment and had the fortune and opportunity to meet and discuss the successes and conundrums of Templary with the other Grand Commanderies within the Department, as well as in-depth discussion of issues with some officers of the Grand Encampment.
 - Grand Master's Banner Bearer
 - In my duties as the grand master's Banner Bearer, I was present at the Grand Encampment of Knights Templar Easter Sunrise Service in Washington D.C., where I followed the color guard from the Grand Commandery of Virginia and led the Most Eminent Grand Master to the celebration.
 - As a note of personal pride, I was also accompanied in this effort by my son, DeMolay member Jack Helcl. Jack had the singular and unique experience of being the <u>very first</u> member of DeMolay to both march in with the Grand Master and carry the flag of the Order of DeMolay in the history of the Grand Encampment's Easter Sunrise Service.
- Legislative Activities:





- Special Grand Commandery Legislative Session- On Saturday, February 15th, the Grand Commandery held a Special Conclave over Zoom for the review, discussion, vote, and acceptance of several amendments to our Grand Commandery Constitution. Both the planning of the event and the many amendments to be addressed were the efforts of both Sir Knight Clinton Christensen, Grand Generalissimo, and me. I am pleased to report that the logistics of holding the session, the session itself, and the many housekeeping amendments that were presented all went well and have contributed to the overall health of Templary in Minnesota
- I was also tasked by our Grand Commander with the crafting of an amendment from the floor for this Grand Session regarding life membership disbursements to Commanderies that are not adhering to annual reporting/returns requirements.
- I was asked to review Section 45(a) of the Grand Commandery's Constitution regarding attendance requirements of Grand Officers for all meetings called by the Grand Commander. Section 45 (a) states,

Section 45.

Section 45(a). A Grand Officer-attendance problem occurs if any of the following conditions exist regarding a Grand Commandery Officer's attendance to stated Grand Commandery meetings (attendance by Grand Commandery Officer(s) either in person, telephone, or by teleconference/video-conference is considered acceptable for the minimum requirements established within this policy):

- 1. The Grand Officer has three notified or unnotified absences in a row.
- 2. The Grand Officer misses one third or more of the total number of Grand Commandery meetings within the year of their term of office.

Due to ongoing concerns of absenteeism by one or more Grand Officers at required Grand Commandery meetings, as the Grand Captain General it was within the purview of the Office to conduct reviews of these concerns, and advise the Grand Commander and Deputy Grand Commander of my findings; more so as a multiple-year history of this issue has become more prevalent with some members of the Grand Commandery officer line. As the Grand York Rite bodies, in addition to the Grand Commandery, have had many instances of members holding Grand offices engaging in nonfeasance over the past 20 years that adversely impacted the overall health of the York Rite in Minnesota – up to, and including, some executive office holders within the Grand York Rite. Many of these instances could have been mitigated had members raised their concerns and leaders had the constancy to make tough decisions and best, if unpopular, calls to stem default voting practices based on the philosophy of "tradition prevailing."

Committee Activities:

 As Chair: The Honor Guard, the Uniform and Drill, and Awards & Honors committees, respectively.





- Regarding the Uniform and Drill committee, in consultation with the Grand Commander, it was determined that these tasks and duties would be assimilated by the Grand Honor Guard committee.
- The activities of the committees for the Honor Guard and Awards & Honors can be found in the individual reports of those respective committees within the annual preprints.
- As committee member:
 - Financial and Budget: most activities were conducted during the monthly meetings of the Grand Commandery officer corps.
 - Membership: None to report, as the committee did not meet in the 2024-2025
 Templar year.
 - Necrology: I have been assisting our Excellent Grand Prelate, SK James E Turner, Jr with the planning and program for the annual Grand York Rite Memorial Service, which will occur on Thursday, June 26, 2025.
- Additional actions and activities:
 - Hiawatha DeMolay
 - I have been made an accredited advisor for Minnesota DeMolay, and more specifically the Hiawatha Chapter. I hope to use this new status to build more robust connections between the young sirs of Minnesota DeMolay, and our own magnanimous Order.
 - Grand Master's Own and the Minnesota Grand Honor Guard:
 - I have been tasked by our Most Eminent Grand Master to lay out the groundwork, structure, and implement a new Grand encampment unit which will be known as "The Grand Master's Own," and which will become the Honor Guard to the Office of the Grand Master. As this will take some of my bandwith, and does so at the same time I begin at Hamline University in their Master of the Study of Law program, I will be passing the command of the Grand Honor Guard to Sir Knight James Helms. More on that can be found in the 2024-2025 Grand Honor Guard report within these preprints.

My eternal thanks to all for once again being entrusted with the office of Grand Captain General by the Sir Knights of Minnesota. Being granted that trust has been an absolute honor, to which my only hope is that I have met the individual and collective expectations of my fellow Sir Knights. It is a continued privilege to be at the service of the Grand Commandery of Minnesota and our Sir Knights in one capacity or another for the past 12-plus years, and hope that I may continue to do so into the future.

RE: Annual report of the Grand Treasurer

As the Grand Treasurer, it was again my honor to be entrusted to manage the financial records for the Grand Commandery of Knights Templar of Minnesota.

This was a busy year. My focus was getting the Life Membership certificate records entered electronically to verify what funds should be allocated to each Commandery. The process involved entering 2203 certificate numbers based on the Commandery and recording how much that certificate was purchased for. This next year, if elected to continue as Grand Treasurer, I'll be matching the Sir Knight's name to each certificate to ensure that Sir Knight's Commandery is credited with the correct amount. I'll be working with our Grand Recorder to get these records entered in MMS. Once loaded into MMS, I'll be able to determine if the Sir Knight affiliated/transferred to a different Commandery and reallocate the funds if necessary.

During this past year, I also served on the Investments and on the Financial and Budget committees. We were able to successfully transfer the Benevolence Fund and Holy Land Pilgrimage Fund accounts to our account manager. The Education account was also migrated and will be fully migrated shortly.

Please note: Over time, due to previous loss of principal of the Life Membership Fund account, \$59,467 was transferred from the General Fund to the Life Membership Fund to bring the Life Membership Fund back to the total amount that the Sir Knights originally purchased their certificates for.

It would be my honor to continue to serve the Grand Commandery of Knights Templar of Minnesota as its Grand Treasurer for the ensuing year – With the approval of the Nominating Committee and the Sir Knights present at the Annual Conclave.

While he would like to visit Holy Land, his situation has changed. He was re-assigned to another Church in Papillion, Nebraska. The Grand Commandery of Minnesota has elected to send him to the Holy Land and pay any additional fees. I have left messages with the Grand Commandery of Nebraska to make some contact with him but have yet to receive any response as of the writing of this report.

Meanwhile the Grand Encampment of Knights Templar of the United States reached an agreement with Gate 1 Travel Agency in the middle of April 2025 to send (2) groups of 30+ people for the 2026 Holy Land Pilgrimage. Due mostly due to the cost of airfare there is an additional cost of \$800.00 plus the domestic flight, whatever that may be.

As Captain of the Grand Honor Guard of the Grand Commandery of Minnesota, I submit this summarized report of activities of the Grand Honor Guard for 2023-2024:

SK Helcl was named the Uniform and Drill committee. In consultation with the Grand Commander, it was determined that these tasks and duties would be assimilated by the Grand Honor Guard committee; and that the committees would be suspended until otherwise activated by the Grand Commander.

The Honor Guard engaged in the following duties at the 69th Grand Encampment Triennial – Salt Lake City. Members of the Honor Guard formed the reception lines and performed presentation of the Colors for the opening of the 69th Triennial, led by the Captain of the Honor Guard.

The Honor Guard conducted flag presentations for the following events:

Corinthian Lodge Installation - December 1st, 2024

Initially, the GCHG was requested for the presentation of the Colors for the Installation of Officers of the Grand Lodge of Minnesota. However, after discussions with our now Grand Master, MWB Robert S. Davis, it was determined that the agenda and sequence of events that day would have led to a conflict with other Masonic organizations and with proper flag code and etiquette, and the deployment request was cancelled by mutual agreement.

The Grand Honor Guard's first responsibility and duty is to attend to the Sir Knights who have been called home by our Father, and aid and assist their families. While the Honor Guard is always at the ready to respond to the call for casket guard, ramp guard, and other funerary duties; we are also quite thankful when these duties are not required.

The Honor Guard was requested to perform casket guard for the December 8th , 2024, funeral of Past Grand Master Phillip Soderberg, but as that official request was received by the Honor Guard less than five days prior, we were not able to mobilize enough members to perform that duty adequately in that short period





Members of the Honor Guard continue to aid and assist Commanderies in drill, ceremony, and uniform protocols. Additionally, the Honor Guard will respond to aid and assist Commanderies in meeting quorum for opening and conducting business. SECTION 108

Whatever the current membership data system in use authorized by the Grand York Rite Bodies

Section 1. Current membership data system.

The authorized membership data system authorized by the Grand York Rite Bodies will be the official digital repository of all membership records of the Grand Commandery of Minnesota.

Section 2. Use of Data/Content.

Anyone granted access will agree that the use of the data is only as intended by the membership data system. Each individual granted access to data holds a position of trust and must preserve the security and confidentiality of the information he/she uses or accesses. Users are required to abide by all applicable Federal and State guidelines and Masonic policies regarding confidentiality of data. Any individual with authorized access to data must not divulge this information outside except for approved Masonic business. You may not use or export or reexport any content or any copy or adaptation of such content, in violation of any applicable laws or regulations, including without limitation United States export laws and regulations.

Section 3. Users Must:

- A. Access data solely in order to perform his/her responsibilities.
- B. Not seek personal benefit or permit others to benefit personally or professionally from any data.
- C. Not permit unauthorized use of any information.
- D. Not enter, change, delete or add data to any record outside of the scope of his/her responsibilities.
- E. Not include or cause to be included in any record or report, a false, inaccurate or misleading entry known to the user as such.
- F. Not alter or delete or cause to be altered or deleted from any records, report or information system, a true and correct entry.
- G. Not release data other than what is required in completion of his/her responsibilities.
- H. Not exhibit or divulge the contents of any record or system information to any person unless it is necessary for the completion of their responsibilities.

Section 4. Your Login and Password.

A. To protect the account information of our users, you are assigned a unique user name. These unique identifiers are disclosed only to you. You are responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and you agree to and accept sole responsibility for any and all activities that occur under your account or password. You agree to notify the Grand Recorder immediately of any unauthorized use of your account or password, or any other breach of security. However, you may be held liable for losses incurred to the system or any other user of or visitor to





the site due to someone else using your user login and password.

Section 5. Commander Responsibilities:

- A. Shall ensure the utilization of the membership data system to manage all membership records of the Commandery in a timely manner.
- B. If necessary: May designate one Information Technology (IT) Representative to assist with managing a Commandery's membership records and will comply with the Recorder responsibilities in Section 6.
- C. Shall notify the Grand Recorder immediately of any changes to the office of Recorder or IT Representative in order that old accounts may be deactivated, and new accounts established.

Section 6. Commandery Recorder Responsibilities:

- A. Shall take and be familiar with any training offered by the membership data system Administrators and the Grand Recorder's office in order to be able to utilize all aspects of the system.
- B. Shall be responsible for maintaining all commandery membership records in MMS, making necessary changes within 30 days of their occurrence.
- C. Shall annually, within 30 days of the installation of officers, update the list of officers of the Commandery.
- D. Recorder's and IT Representatives shall log in to membership data system no less than monthly to maintain access credentials and to make any approved membership changes.
- E. Shall submit to the Grand Recorder a list of all remissions for the reporting year by December 31 each year. Remissions shall include member's full name and type of remission, i.e., Health/Other, or 50-Year Member. Failure to submit remissions list to Grand Recorder by the due date will negate any credits for remissions in the Annual Return calculations for the reporting year.

Section 7. Grand Recorder Responsibilities:

- A. Shall manage and monitor all user accounts, coordinating with System Administrators for all activations and deactivations in a timely manner.
- B. Shall annually, within 30 days of the installation of officers, update the list of grand officers of the Grand Commandery.
- C. Shall report to the Grand Commander any deficiencies in utilization of membership data system by any Commandery.
- D. Shall run an Annual Statistical Report for each Commandery immediately following the close of the reporting year.
- E. Shall generate a bill for each Commandery based on the Annual Statistical Report of each Commandery, and which shall include all applicable credits and debits, in accordance with the duties and times as written in the Grand Commandery Regulations.
- F. Shall not allow any prior year corrections in a billing cycle due to the failure of any Commandery Recorder or IT Representative to manage and maintain their membership





records.

LEGISLATION TO BE CHANGED: X Constitution Statues Rules **ARTICLE/SECTION NUMBER** Section 46

ARTICLE/SECTION NAME

1. CURRENT WORDING OF SECTION TO BE CHANGED:

A Commandery may from time to time, by a majority vote, remit the dues of a member either before or after such member shall have been stricken from the rolls for nonpayment of such dues, who for any reason is financially unable to pay them. The Commandery, however, shall be liable for and must pay to the Grand Commandery the annual dues or per capita tax of all members on its rolls, provided however, that when any Constituent Commandery shall have remitted the dues for any year of a member on account of financial inability to pay said dues, or per capita tax, the Grand Commandery shall cancel or remit, the annual dues or per capita tax of said member for that year payable to it by said Commandery, except that portion which is payable to the Grand Encampment by the Grand Commandery.

For annual dues for each member in good standing in the Constituent Commanderies, except those knighted during the year plus the current Grand Encampment per capita \$16.00

In addition to the above income, constituent commanderies shall pay to the Grand Commandery, the current Life Sponsorship fee for each newly created Sir Knight as well as each new affiliated Sir Knight.





A Commandery may from time to time, by a majority vote, remit the dues of a member either before or after such member shall have been stricken from the rolls for nonpayment of such dues, who for any reason is financially unable to pay them. The Commandery, however, shall be liable for and must pay to the Grand Commandery the annual dues or per capita tax of all members on its rolls, provided however, that when any Constituent Commandery shall have remitted the dues for any year of a member on account of financial inability to pay said dues, or per capita tax, the Grand Commandery shall cancel or remit, the annual dues or per capita tax of said member for that year payable to it by said Commandery, except that portion which is payable to the Grand Encampment by the Grand Commandery.

4. ENTIRE PARAGRAPH AS INTENDED TO READ IN THE CODE OF LAWS:

Section 46. The revenue of the Grand Commandery of Minnesota shall be derived as follows:

In addition to the above income, constituent commanderies shall pay to the Grand Commandery, the current Life Sponsorship fee for each newly created Sir Knight as well as each new affiliated Sir Knight.
